Toxic Products

Products that display the poison symbol, the word "Danger" and are a liquid or aerosol.

Maximum container size is 10 liters and 680 grams or 24 ounces for aerosols.

Products Accepted Include:

- Furniture stripper
- Automotive additives
- Lubricants
- Tar and bug remover
- Kerosene
- Mineral Spirits
- Paint thinners (e.g. Varsol)

Physcially Hazardous

Products that display both the flammable symbol and explosive symbol. Container must be non-refillable and a maximum size of 5 kg.

Products Accepted Include:

- Non-refillable fuel gas cylinders
- Single Use Fuel cylinders
- Single Use Camping cylinders
- Single Use Butane cylinders

Fluorescent Lights

Products Accepted Include:

- 8 ft Fluorescent Bulbs
- 4 ft Fluorescent Bulbs
- O, U, D Shaped Fluorescent Bulbs
- Compact Fluorescent Bulbs

Note: Commercial use fluorescent bulbs accepted

Pesticide Products

Consumer pesticides that have the poison (skull & cross bones) symbol, Pest Control Product (PCP) number and the word "Domestic" on the label.

Maximum container size is 10 litres and 680 grams or 24 ounces for aerosols.

Products Accepted Include:

- Liquid Pesticides
- Powdered Pesticides
- Solid Pesticides
- Aerosol Pesticide Container

Please Note:

All materials must be in original container and clearly labelled for the health and safety of all handling the materials



Paint Products

Maximum container size is 25 litres for paint and 680 grams or 24 ounces for paint aerosols.

Products Accepted Include:

- Interior and exterior water-based (e.g. latex, acrylic) and oil-based paint
- Already empty paint containers
- Architectural paint (e.g. alkyd, enamel)
- Deck, porch and floor coating (including elastomeric)
- Varnish and urethane (single-component)
- Concrete and masonry paint
- Drywall paint
- Undercoats and primers (e.g. metal, wood, etc.)
- Stucco paint
- Marine paint*
- Wood preservatives*
- Wood finishing oil
- Melamine, metal and anti-rust paint, stain and shellac
- Swimming pool paint (single-component)
- Stain blocking paint
- Textured paint
- Block fillers and sealers
- Wood, masonry, driveway sealers and water repellents (non-tar based or non-bitumen based)
- Paint aerosols of all types including automotive, craft and industrial products

*Not accepted if registered under Pest Control Products Act

Note: Commercial use paint accepted

Products Not Accepted

- Industrial paint and finishes
- Paints or wood preservatives that are registered as a pesticide under the Pest Control Products Act (has a P.C.P Registration number on the label)
- Non-Aerosol craft paint
- Auto Body - two-part or component paints containing a catalyst or activator
- Traffic or line marking paint
- Resins, fibre-glass
- Colorants and tints
- Nitro-cellulose based paints

Please Note:

All materials must be in original container and clearly labelled for the health and safety of all handling the materials



Flammable Products

Products that display the flammable symbol and are a liquid or aerosol.

Maximum container size for flammable liquids is 10 litres and 680 grams or 24 ounces for aerosols.

Products Accepted Include:

- Acetone
- BBQ lighter fluid
- Camping fuel
- Fondue fuel
- Flammable degreasers
- Flammable lubricants
- Flammable liquid adhesives
- Flammable fuel treatment and additives
- Methanol (Methyl hydrate)
- Paint stripper
- Paint thinners
- Paint and varnish remover
- Turpentine
- Other flammable solvents
- Gasoline (in a CSA approved container only)

Corrosive Products

Products that display the corrosive symbol, and are a liquid, aerosol or solid.

Maximum container size is 10 litres and 680 grams or 24 ounces for aerosols.

Products Accepted Include:

- Rust remover
- Masonry cleaner
- Pool and hot tub cleaners

Please Note:

All materials must be in original container and clearly labelled for the health and safety of all handling the materials

Products Not Accepted

- Products used for Commercial, Industrial or Agricultural purposes
- Products with a WHMIS or GHS label (symbol contained in red diamond)
- Ammunition
- Explosives
- Drugs and medicines
- Diesel
- Medical sharps
- Flammable liquids, corrosives or toxics sold in containers greater than 10 litres or greater than 680 grams/24 ounces for aerosols
