BEACONIA WELL

The Office of Drinking Water (ODW) visited the Beaconia Pail Fill to conduct their annual compliance inspection on September 9, 2020. The ODW noted and instructed that the free flowing artesian well as it is operating, does not comply with Provincial Legislation and is in contravention of the Groundwater and Water Well Act. Since then, we have been directed by regulators that some changes must be made, including a flow control device and disinfection process to ensure the safety of the water for human consumption.

Council is in agreeance that maintaining the public's access to water free of charge at this specific location is preferred. However the requirements to achieve compliance come with significant capital investment and ongoing operational expenses. For these reasons we are gathering public usage information to better inform the decision making process.

HIGHLIGHTS OF THE BEACONIA WELL SURVEY

A total of 206 completed surveys were received by the cut off date of June 24, 2022. Not all questions were answered by each resident who took the survey, but our staff took the data available and compiled to present accurate results.

Over 80% of respondents believe a public, potable water supply in the area is somewhat or very important

Of those who use the Beaconia Well as their main source of potable water:

32.04% of respondents are permanent residents 61.17% of respondents are seasonal residents 5.88% do not reside in the RM of St. Clements

Of those who use the Beaconia Well as their main source of potable water:

52.43% said that they would still use the Beaconia Well if the water was chlorinated 23.3% said they were unsure if they would still use the Beaconia Well if the water was chlorinated

24.27% said they would not use the Beaconia Well if the water was chlorinated

Of those who use the Beaconia Well as their **main source** of potable water:

27.18% said they would be willing to pay a fee for service

48.54% said they were unsure if they would be willing to pay a fee for service

24.27% said they would not pay a fee for service

Part of the required upgrades includes disinfection. Would you still use the Beaconia Well if the water was chlorinated?

To achieve regulatory compliance, significant capital investments and operational expenses will be required. If there were a fee for service, would you continue to use this water supply?
