General

The RM of St Clements intends on participating in the provinces Dutch Elm control program for municipalities and requires a private contractor to perform works associated with the program. This work entails the control and removal of elm trees identified by Manitoba Conservation along with the disposal of the same at an approved identified site. This would be an agreement for 2024/2025. Tree removal work must completed by February 1st, 2025. Work is limited to only the area within the confines of the RM's agreement with the province, identified in appendix B.

All works must comply with the Province's regulations, including, but not limited to the following.

Removal

Trees must be removed flush to the ground, debarked to the soil line, and properly disposed of. Flush to the ground is defined as up to 1 inch high. Any

equipment used must be disinfected with methyl hydrate before servicing other healthy elm trees. The RM prefers that the work is completed with a certified Arborist on site.

The Contractor shall leave the property in the condition it was prior to removing the tree(s). All wood material to be removed, including all notches, and branches to be raked up and removed as well.

Any problems discovered after snow melt must be resolved by the contractor within 2 weeks of discovery, weather permitting. The Municipality shall undertake matters to resolve any issues lasting longer than 2 weeks and use remaining performance bond to re-coupe those costs.

property to remove the applicable trees. If there is no one home, the contractor will leave a calling card for the property owner to contact them, again, prior to any removal. Contractor is to supply copy of notice with bid.

The Contractor shall indicate the start date and estimated timeline to complete this job in the Bid Form.

Performance Bond

A Performance Bond, conditioned on the due performance of the terms of the contract for the amount of **25% of the Contract Price**, shall be furnished by the Service Provider. The Performance Bond shall remain in full force and virtue for at least until September 30, 2025.

Prime Contractor

The successful bidder shall be deemed the prime contractor for the project and is solely responsible for the public safety at the site (s) and for securing the site at all times. The successful bidder shall carry out work in accordance with the Construction Safety Code in force at the place of work and in accordance with the applicable Workplace Safety and Health Act Regulation for Manitoba. The Contractor shall insure that when work is stopped, the Contractor leaves the site (s) in a safe and secure manner. At the discretion of the Director of Public Works, of his/her designate, may require additional safety precautions over and above the code during construction.

Insurance

The successful Contractor shall, at their own expense, obtain Comprehensive General Liability (Occurrence Form) policy written in the Contractor's name and including the RM of St. Clements as an additional named insured in the amount of not less than \$2,000,000.00 (two million dollars) inclusive for bodily injury and/or property damage for any one occurrence or series of occurrences arising out of one cause. Legal or defence costs incurred in respect of a claim or claims shall not operate to decrease the limit of liability. The bidder shall provide proof of liability insurance with bid submission.

Bid Price Tree Removal

Bid price shall be per tree, based on the diameter of the tree, as indicated in the distribution of tree sizes. The bid price shall be all inclusive, including but not limited to:

- -Labor, equipment, and material to removal and properly disposal, including any clean up required, and including equipment mobilization and demobilization.
- -Restoration of any damages incurred, such to restore to pre-cutting / removal condition.
- -Any clearances of overhead wires, and locates required, including any permits required to complete the job.
- -All incidental charges, insurance, and all taxes, except GST

Appendix A is a preliminary estimate provided by Manitoba Conservation for the 2024/2025 requirements. The RM of St. Clements reserves the right to increase or decrease quantities. These are estimated quantities to be used for bid comparisons. The Contractor shall be paid for the actual trees removed. All prices quoted shall remain valid for thirty (30) days from close of RFP.

One Year Extension

The Municipality may extend this agreement, by mutual consent for the 2025/2026 Dutch Elm tree removal season. Prices would remain the same as quoted for the 2024/2025 Dutch Elm season. Any extension would be provided in writing.
